Modern Camping is limited to *assigned lot location* at a cost of \$5 per space in designated camping area and ONLY to *registered participants*. Campgrounds open at 8 a.m. EST Friday, October 11, 1996 and *must be vacated by noon* Monday, October 14, 1996.

MODERN CAMPING is limited to a campground adjacent to the festival grounds, and pre-registration is required. *All modern campground spaces will be assigned.* If you will be participating with a specific group, and wish to camp with that group, you must specify your group on this registration form. It is imperative to note the size and quantity of all equipment required to be in the modern campground. The modern campground is equipped with *pit toilets, no electricity and no hookups.* NOTE: *The modern campground is for campers and tents only. No unauthorized vehicles will be allowed to remain in the campground area.* Vehicle authorization will be at the discretion of the campground chairperson. Quiet hours are midnight to 7:00 a.m., all generators must be turned off during quiet hours.
