Procedures for the Application and Selection of the NWTA Scholarship

The Selection Committee

- The committee shall consist of NWTA members representing the various communities within the NWTA as evenly as possible.
- Committee members who present a conflict of interest in judging must remove themselves or be removed by the Chair from the selection proceedings. The Chair may or may not choose to replace removed members after the committee has been established in a given year.
- No member with a child, grandchild, or spouse entering an application shall be retained on the selection committee

- given the possible financial benefit to the member in question.
- Given the size of the organization, we recognize that multiple or all committee members may share unit affiliation with applicants, or have acquaintances among the applicant pool. Therefore the Chair will not remove members for this reason. If, however, a member feels a strong and abiding relationship with an applicant, s/he is encouraged to judge for her/himself whether there is a conflict of interest sufficient to remove her/himself.

MICHIGAN EVENTS

At the least few meetings, of the NWTA Board of Directors, I have been hearing concerns about the declining number of events each year, and the need to solicit new events and to try and bet back former events. During the height of the Bicentennial, we had enough events to take up every weekend. In fact we divided the NWTA into three Departments just to divide the National responsibility and staff to handle all of the administrative and command demands. After the Bicentennial, the events and NWTA membership started to dwindle. In 1996 we lost our last Michigan event. Jim McConnell and I were the representatives of the Host Units for this event, and I had the honor in acting in the NWTA Commanders sted as event Commander.

The following is the presentation that I made at the November 1996 NWTA Board Meeting. I present here as the same problems that plagued us then still plague us now, plus, we now have added the cost of high gas prices (for us) and increased costs bourn by the sponsors .

"We have two Michigan events at present time. Monroe and Bowens Mills. These two events are traditionally NOT supported by NWTA Units. Only 5 Units had representation at Monroe and 3 Units had representation at Bowens Mills.

"It is understandable that persons living in Wisconsin may not wish to attend these events due to the long drive. However there are units and reenactors in Michigan, Ohio, Indiana, and Eastern Illinois that also do not come.

"We are in danger is losing the Monroe event. Marian at Bowens Mills has indicated to us that she wants to continue that event.

"I will let Campeau's Company address the Monroe event in which only 56 re-enactors, which includes 24 Men-At-Arms participated.

"At Bowens Mills, I acted on behalf of the NWTA Commander as the Event Commander and as the Unit Commander of the Host Unit. I was terribly embarrassed to accept the \$200.00 check from Marian. We had a total turnout of reenactors of 20, which included 8 Men-At-Arms. People, this is an INSULT to the sponsor and an embarrassment for the NWTA. I have three (3) proposals to make concerning the Bowens Mills event and other NWTA events:

- "1. I propose that the \$200.00 fee paid to the NWTA by Bowens Mills be refunded with a letter of apology signed by the NWTA Commander for the NWTA not supporting this event.
- "2. None of us can be at all of the events. However, with a membership between 600-800 we should be able to have most of the NWTA Units represent by at least one (1) member at each event. That would guarantee at least 50 reenactors at each event.

"I propose that each Unit pledge to have at least one (1) re-enactor at each NWTA event.

"3. My last proposal is that we have a roll call vote for each event. If you as Unit Commander do not feel that you can have a Unit member at a particular event, then vote NO on that event, otherwise vote YES. I further propose, that the Adjutant publish in the statistics the Units that voted Yes for an event and did not have any representation

"When we attend another Units event, we are supporting that Unit. More importantly, we are supporting that Sponsor. If we do not attend an event in sufficient number we are insulting the Sponsor and telling that Sponsor and the public who expects a decent show that we don't care about them or our purposes of Education and Entertainment. We are hurting our own credibility."

The two hundred dollar check was refunded to Bowens Mills, and Jim McConnell and I discontinued as Unit Hosts for this event, with no-one MAY/JUNE PAGE 3

else picking up the event. The Monroe event continued for a couple of more years, without NWTA representation, as a timeline event, but was discontinued in the early 2000's due to increased costs and cuts in budget. Today, there are no Revolutionary War events in Michigan, for the NWTA or BAR, but F&I and Civil War events are flourishing. An embarrassing note is that at the Kennsington and Frankenmuth events (both on the east side of Michigan), the F&I Units are re-enacting Revolutionary War battles, and doing a better job than the NWTA does.

From the journal of Henry Melchior Mulenberg: June 3, 1778. My wife busied herself distilling some rose water and also mending clothes, Woolen and linen goods are so scarce and exorbitantly dear that they are hardly to be obtained at all; so one is obliged to cut up old clothes, stitch the rags together, and be clothed in harlequin fashion, Fortunately I still have left an old preaching gown with which I can cover up the rest of the heterogeneous ensemble when I have to conduct acts of worship in the churches.

Evaluation Criteria:

- Applicants will be evaluated by the committee members based upon the information provided in the application materials.
 - Committee members will consider the following list of criteria, but they are free to take other factors presented in the application into consideration.
- Academic performance and goals
- NWTA involvement (as demonstrated through the essay portion of the application)
- Volunteer and extracurricular activity outside of the NWTA

Disbursement Procedure:

The NWTA Treasurer will disburse the awards by check by August 15th.
